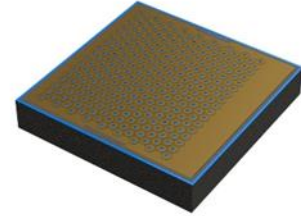

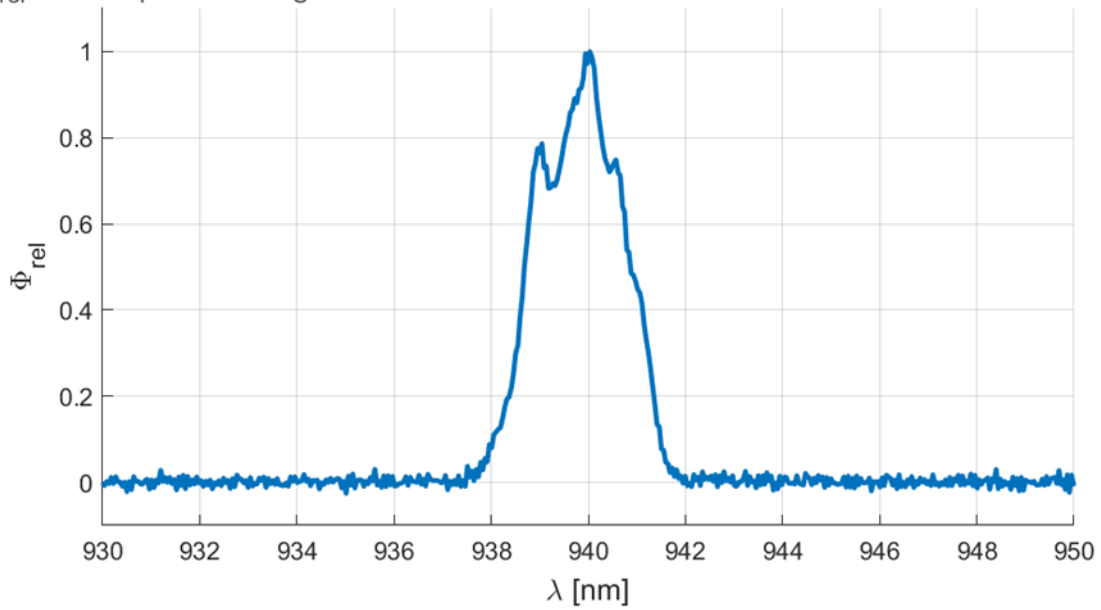

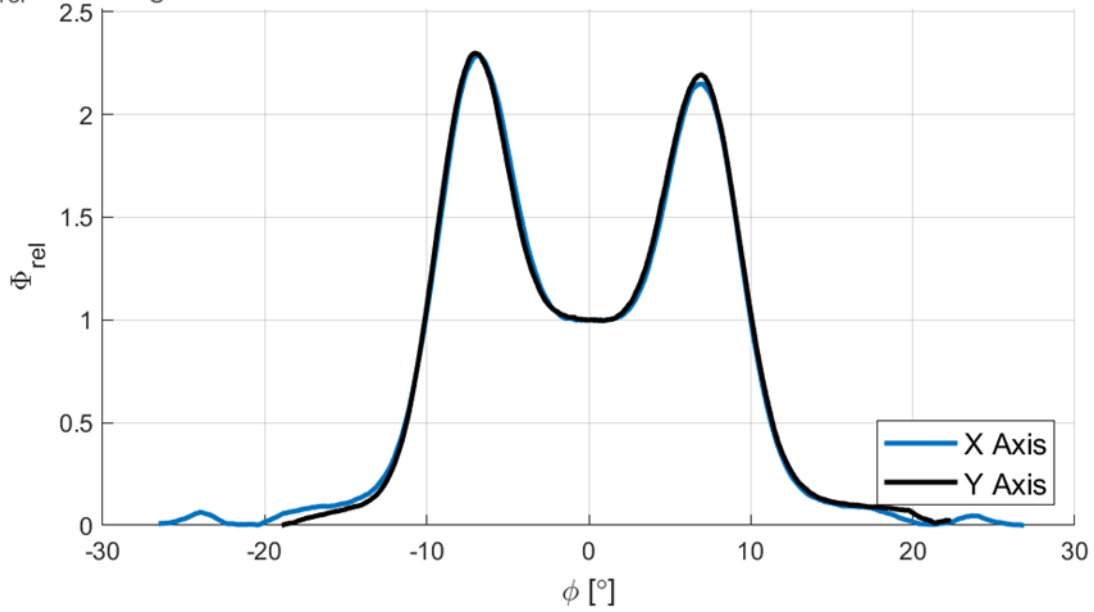
Relative Spectral Emission ¹⁾

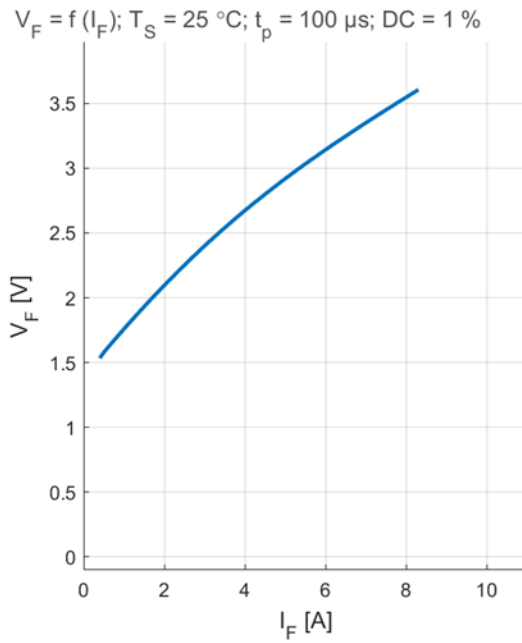


Radiation Characteristics ¹⁾

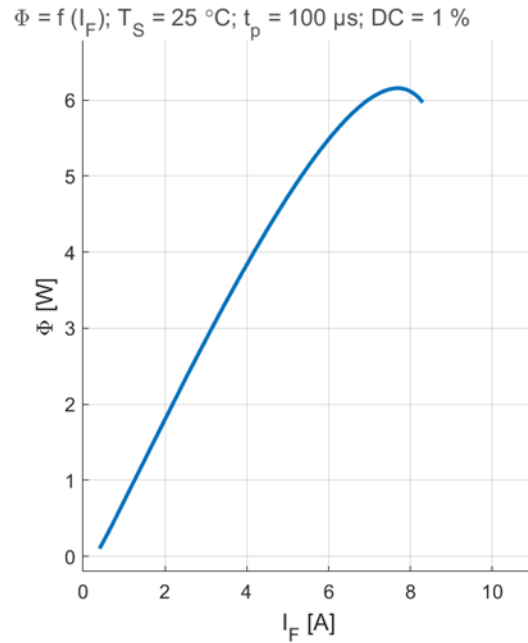

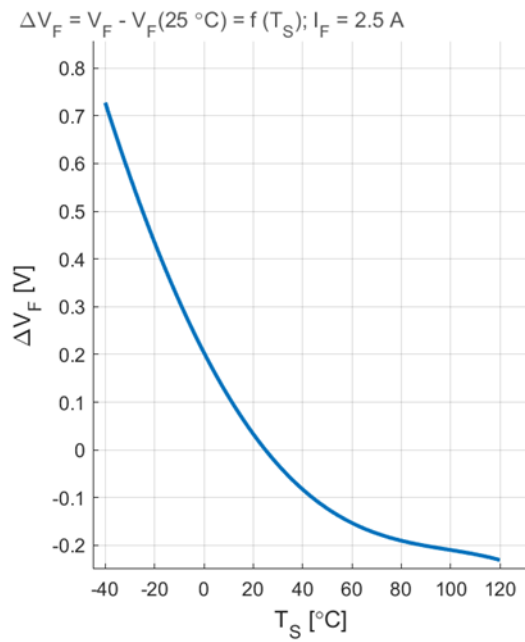
Forward Voltage ^{1) 2)}



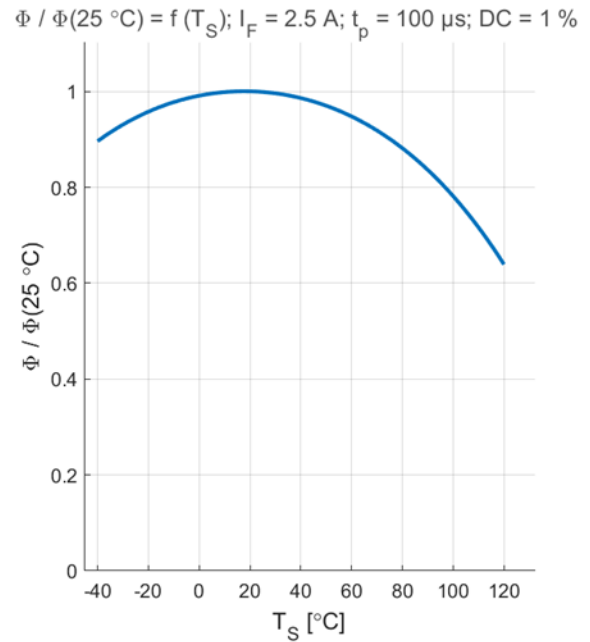
Optical Output Power ^{1) 2)}



Relative Forward Voltage ¹⁾

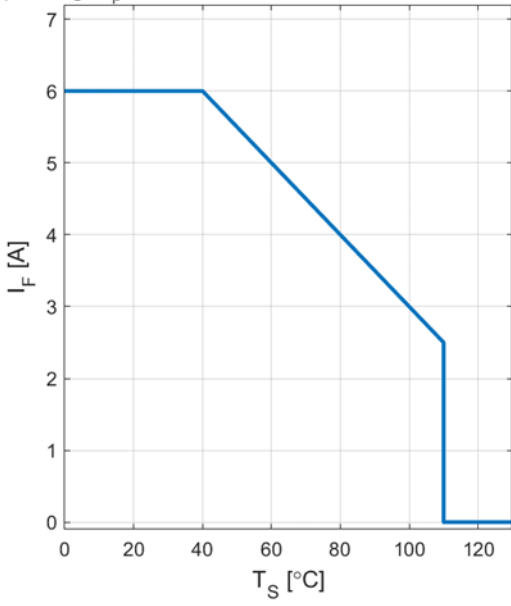


Relative Radiant Power ¹⁾



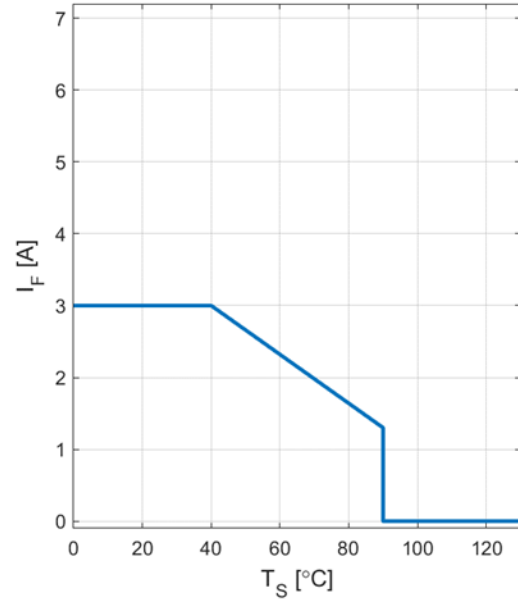
Max Permissible Pulse Current

$I_F = f(T_S); t_p = 100 \mu s; DC = 1 \%$

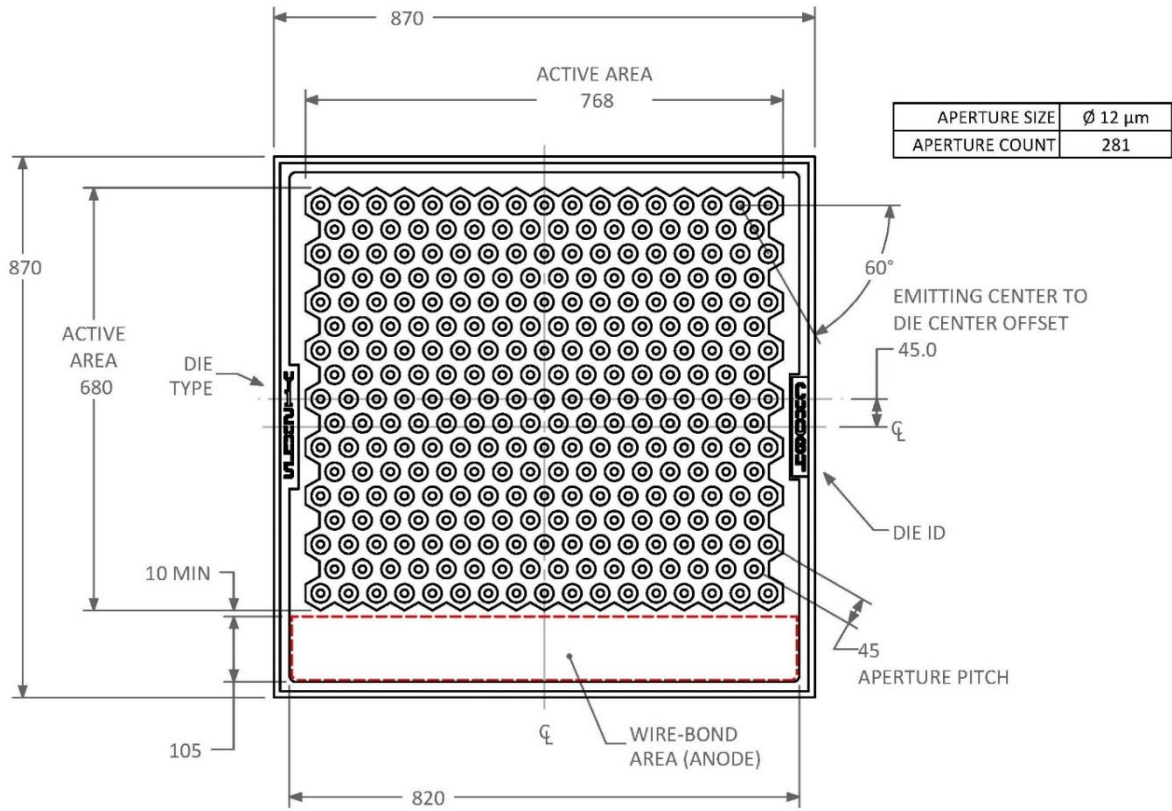


Max Permissible Current

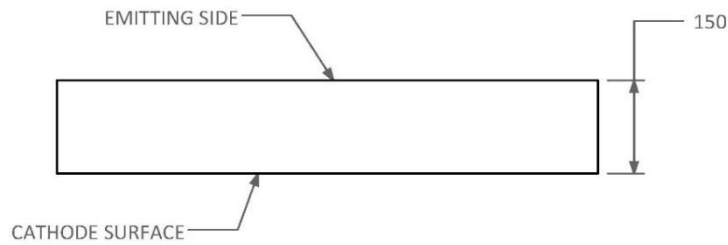
$I_F = f(T_S); DC = 100\%$
