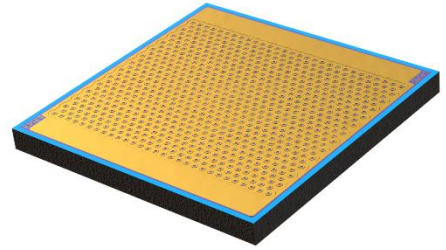

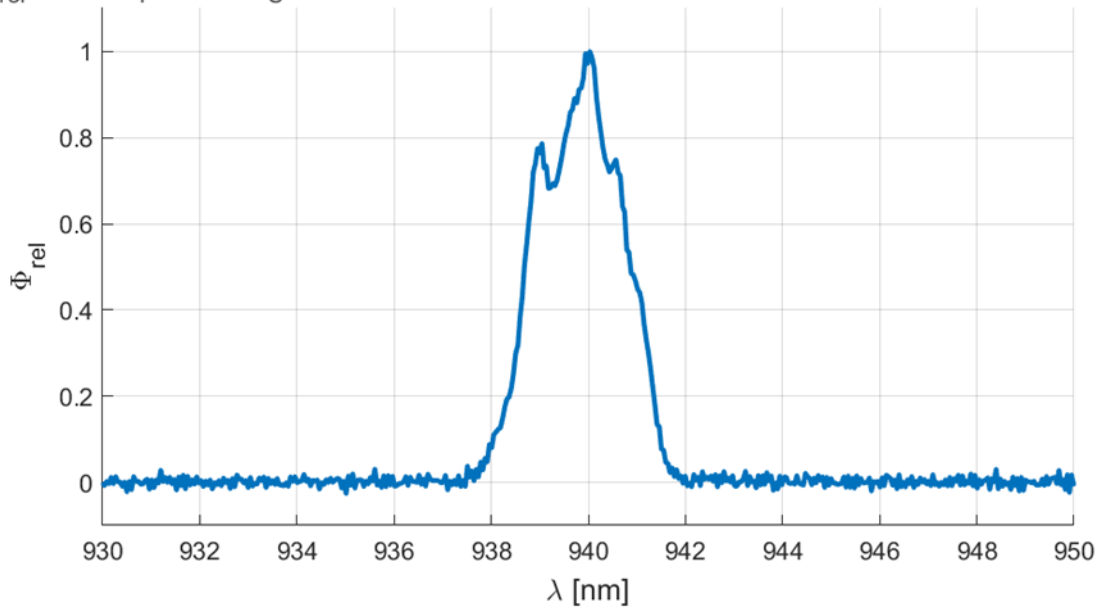

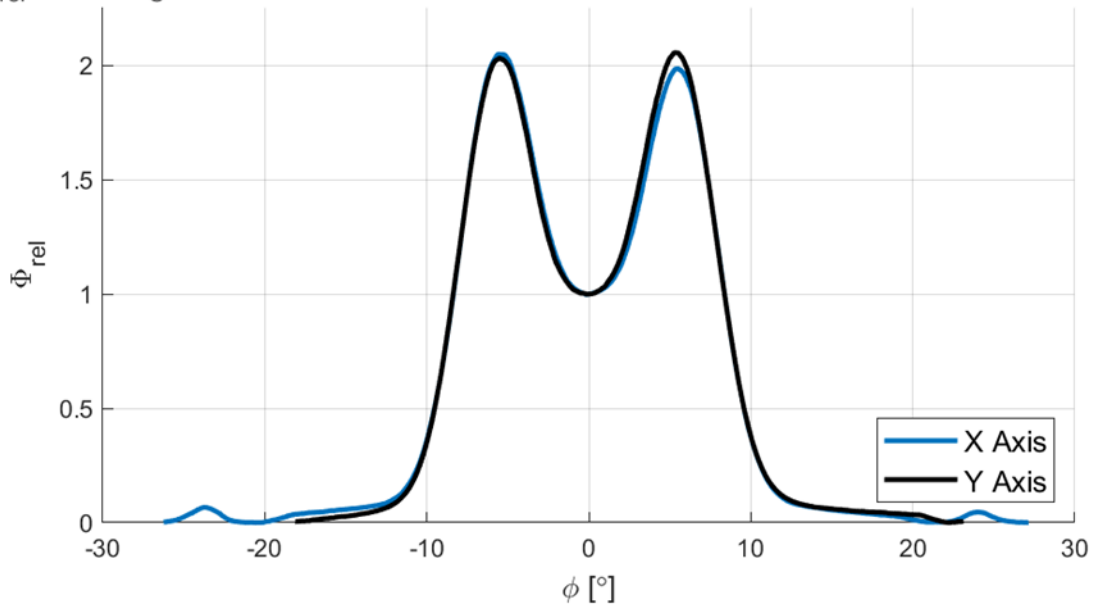
Relative Spectral Emission ¹⁾

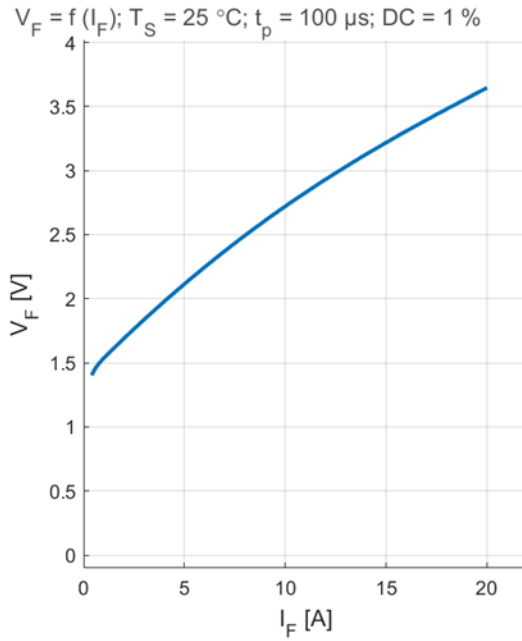


Radiation Characteristics ¹⁾

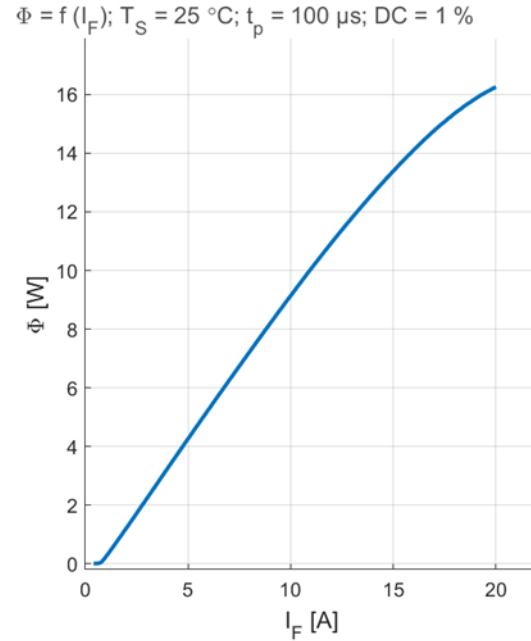

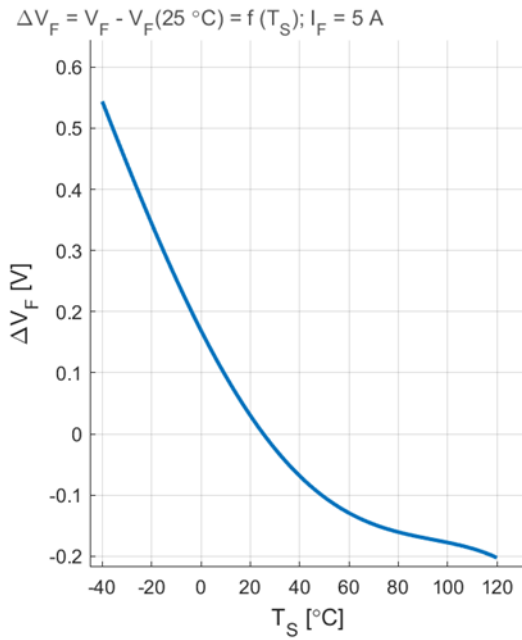
Forward Voltage ^{1) 2)}



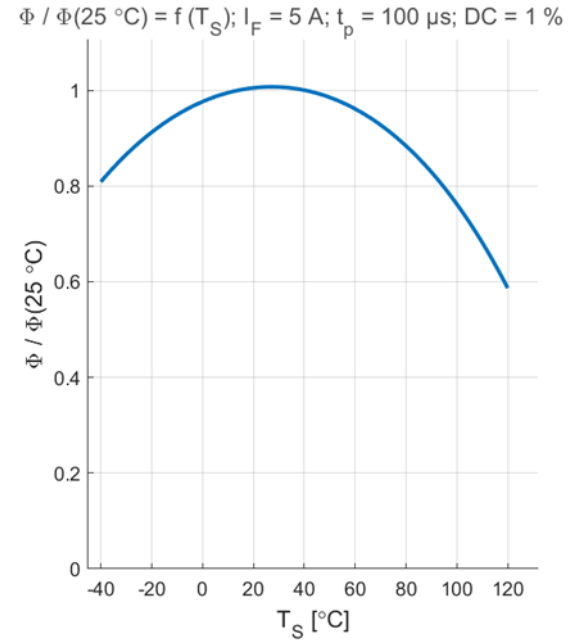
Optical Output Power ^{1) 2)}



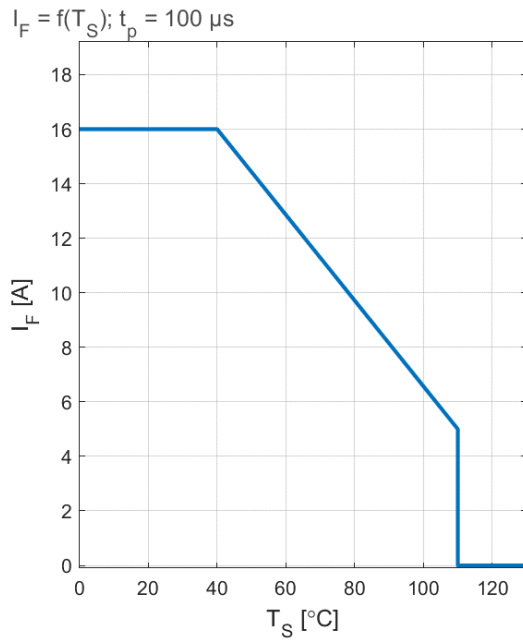
Relative Forward Voltage ¹⁾



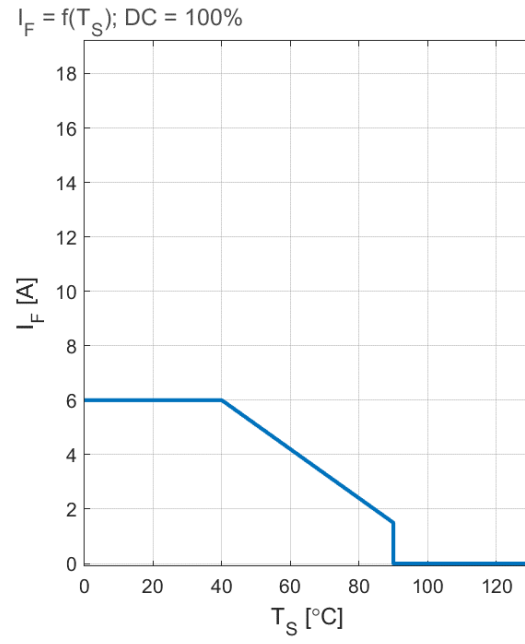
Relative Radiant Power ¹⁾
